## Re: *Central Kentucky Transmission Company*, Docket No. RP21-\_\_\_-000 **Penalty Revenue Crediting Report**

Dear Ms. Bose:

Pursuant to Section 19.6 of the General Terms and Conditions ("GTC") of Central Kentucky Transmission Company's ("Central Kentucky") FERC Gas Tariff, First Revised Volume No. 1, Central Kentucky must file a report with the Federal Energy Regulatory Commission ("Commission") within 60 days of the close of each Central Kentucky contract year (November 1 to October 31) showing any Penalty Revenues Central Kentucky has received during the contract year, any Central Kentucky costs to net against the Penalty Revenues, and the resulting Penalty Revenue Credits due to Non-Penalized Shippers for each month of the contract year.<sup>1</sup>

Central Kentucky did not collect any penalties for the 2019-2020 contract year and therefore has no Penalty Revenue Credits to report to the Commission. Central Kentucky requests that the Commission accept this Penalty Revenue Crediting Report as consistent with GTC Section 19.6.

<sup>&</sup>lt;sup>1</sup>On September 18, 2020, FERC authorized Central Kentucky to abandon, by sale, certain certified interstate pipeline facilities known as the KA-1 North Facilities to Columbia Gas Transmission, LLC and directed Central Kentucky to cancel its FERC Gas Tariff, First Revised Volume No. 1. ("Tariff"). In its December 10, 2020 Order, the Commission accepted Central Kentucky's filing to cancel its Tariff effective December 1, 2020 or the actual closing date of the sale. The sale of the KA-1 Facilities from Central Kentucky to Columbia occurred on December 11, 2020. Therefore, this will be the final Penalty Revenue Crediting Report for Central Kentucky.
