Penalty Revenue Crediting Report

Dear Ms. Reese,

Pursuant to Section 19.7 of the General Terms and Conditions (“GTC”) of Millennium Pipeline Company LLC’s (“Millennium”) FERC Gas Tariff, First Revised Volume No. 1, Millennium must file a report with the Federal Energy Regulatory Commission (“Commission”) within 90 days of the close of each Millennium contract year (November 1 to October 31) showing any Penalty Revenues Millennium has received during the contract year, any Millennium costs netted against the Penalty Revenues, and the resulting Penalty Revenue Credits due to Non-Penalized Shippers for each month of the contract year.

Millennium did not collect any penalties for the 2022-2023 contract year and therefore has no Penalty Revenue Credits to report to the Commission. Millennium requests that the Commission accept this Penalty Revenue Crediting Report as consistent with GTC Section 19.7.

Millennium respectfully requests that the Commission grant any waivers which it may deem necessary to accept this filing.
