In accordance with Sections 154.1(d) and 154.112(b) of the Federal Energy Regulatory Commission's ("FERC" or "Commission") regulations,¹ Millennium Pipeline Company, L.L.C. ("Millennium") submits the following tariff record as part of its FERC Tariff, First Revised Volume No. 1.1 ("Tariff"), to reflect an amendment to a negotiated rate agreement to be effective April 1, 2024.

Statement of Nature, Reasons, and Basis for Filing

Millennium is making this filing pursuant to Section 34.11 of the General Terms and Conditions of its Tariff, in order to reflect a negotiated rate transaction that it has amended with BKV Operating, LLC ("BKV") for firm transportation service under Millennium's Rate Schedule FT-1 ("Amendment"). The tariff record identifies and describes the applicable negotiated rate transaction, including the exact legal name of the shipper, the negotiated rate, the rate schedule, the contract term, and the contract quantities.

The BKV transportation contract was previously filed at the Commission and was set forth in the Statements of Negotiated Rates Section in Volume 1.1 of Millennium's Tariff.² Millennium is

merely amending the Statement of Negotiated Rates to reflect the updated start date, end date, and negotiated rate for the BKV transportation contract.
