Statement of Nature, Reasons and Basis for Filing

Section 6.19 of Blue Lake's Tariff provides that Blue Lake will file an annual report on or before May 1 of

state the source, date, volumes, costs and revenues, and all entities from which Blue Lake purchased or sold

operational gas for all operational purchases and sales transactions.

Blue Lake hereby notifies the Commission that it made no operational purchases or sales of gas during the

twelve-month period ending December 31, 2024. Accordingly, no reportable operational purchases and

sales of gas occurred during this time period.
