Dear Ms. Reese:

Pursuant to Section 19.5<sup>1</sup> of the General Terms and Conditions of Columbia Gulf Transmission, LLC's ("Columbia Gulf") FERC Gas Tariff, Third Revised Volume No. 1 ("Tariff"), Columbia Gulf hereby submits for filing with the Federal Energy Regulatory Commission ("FERC" or "Commission") a letter informing the Commission that Columbia Gulf did not collect any penalty revenue for the 2024-2025 contract year. Accordingly, there are no reportable penalty revenue credits for the twelve-month period ending October 31, 2025.

### **Statement of Nature, Reasons and Basis for Filing**

Section 19.5 of Columbia Gulf's Tariff provides that it will file a report within 60 days of the close of the contract year<sup>2</sup> showing, for each month during the contract year, the penalty amounts assessed and actually collected pursuant to the penalty provisions of Columbia Gulf's Tariff, plus any eligible costs incurred by Columbia Gulf that could offset those penalty revenues, and the resulting penalty revenue credits allocated to Non-Penalized Shippers.<sup>3</sup>

Columbia Gulf hereby advises the Commission that it did not collect any penalty revenues for the 2024-2025 contract year. Accordingly, there are no reportable penalty revenue credits for the twelve-month period ending October 31, 2025.


