## STATEMENT OF NEGOTIATED RATES

**Delivery Point(s):** 75,000 Dth/d at Holding Point, Scheduling Point No. 642806  
**Contract Start Date:** The term of this Service Agreement is to commence on the date that is three business days after Transporter provides Shipper with notice of the date on which a new interconnect with Dominion Transmission, Inc. referred to as the Holding Point interconnect has been placed into service.  
**Contract End Date:** October 31, 2019. <sup>3/</sup>

<sup>1/</sup> The designated service agreement does not deviate in any material respect from the Form of Service Agreement contained in Transporter's Tariff.

<sup>2/</sup> Shipper will pay a reservation charge of \$0.0500/Dth/d under Rate Schedule FT-1 of Millennium's Tariff, a commodity charge of \$0.0500/Dth, plus the FERC's annual charge adjustment, and all other surcharges in effect from time to time under Rate Schedule FT-1 of Millennium's Tariff. The reservation and commodity charges specified above are applicable to services during the entire term of the FT-1 Service Agreement, regardless of any otherwise applicable maximum recourse rate under Rate Schedule FT-1.

The rates specified above are also applicable to receipts and deliveries at the following points: Receipts (East Pool, Laser, Stagecoach or any new receipt point between Wagoner and Holding Point) and Deliveries (any current or future mainline secondary delivery points west of the receipt point being used on a primary or secondary basis) (each a "Qualifying Secondary Point"). If Shipper uses any points other than a Qualifying Secondary Point, then Shipper shall pay Millennium's applicable maximum tariff rates solely with respect to those volumes that are received at or delivered to a point that is not a Qualifying Secondary Point.
